

# The Diocese of Kildare and Leighlin Parish Safeguarding Self-Audit for December 2022 – December 2023

#### 1. Introduction

The 2023 Diocesan Parish Safeguarding Self-Audit was carried out to reflect the period between December 2022 and December 2023. Audit forms were distributed to every parish in January 2024. 50 out of a possible 56 parishes returned their audit by July 2024.

The audit is completed as part of our compliance with Standard 7 (Quality Assuring Compliance with the Standards) as set out in the Safeguarding Children Policy and Standards for the Catholic Church in Ireland 2016 developed by the National Board for the Safeguarding of Children in the Catholic Church in Ireland (NBSCCCI).

Local safeguarding personnel, priests and other parish personnel who participated in this auditing process should be commended for their participation and their overall strong awareness of and adherence with safeguarding practices in their parishes.

## 2. Data arising from the audit returns

NAME OF PARISH:	Returns were received from 50 out of a possible 56 parishes.
YEAR UNDER REVIEW:	December 2022 to December 2023.
PERSON(S) COMPLETING AUDIT:	Most forms were completed by the Parish Priest and the Local Safeguarding Representatives (LSR). A small number were completed by priests only or by parish secretaries or by the LSR with the parish secretary.
DATE OF COMPLETION:	All returned forms were completed between January 2024 and July 2024.

## 3. Findings

## Standard 6: Communicating the Church's Safeguarding Message.

There is very strong compliance with having the Policy statement displayed in church porches with only 1 parish not displaying the statement in their porch. There is almost full compliance with having the policy on display in churches sacristies. A quarter of parishes have children's codes of behaviour on display in church sacristies. With 28 parishes having altar servers, best practice would mean that all 28 of these parishes display codes of behaviour for children. Follow up with 12 parishes who have servers and answered no to this question.

20 parishes answered 'not applicable' to having a children's code in sacristies, which reflects the high number of parishes (22/50) where altar servers are not in place.

8 parishes report to having the safeguarding poster up in another language. Posters are available on the diocesan website in Irish, Polish and Ukrainian.

There is almost full compliance with celebret request posters on display in sacristies with just three parishes out of the 50 returns not answering this question.

Almost all parishes said they have the required policy poster on display in parish buildings with a number saying no or n/a, in cases where the parish has no other building other than the Church. Just over a quarter report to having the code of conduct for children on display, again with a number choosing no or n/a as they do not have any parish halls or centres.

Almost all parishes said they have the safeguarding leaflets developed by the Diocesan Safeguarding Committee available in churches and parish centres. Those parishes who reported "no," have since been contacted and leaflets will be provided.

All 50 parishes report to having Local Safeguarding Reps appointed with the average number per parish being two reps. Almost all parishes make the names of the safeguarding representatives available locally. Some new safeguarding representatives require to complete their full day training and some also require refresher training.

Only 4 parishes with CCTV/ Webcams reported having no signage and did note in the audit that they would follow up on this as an action.

## **Standard 1: Creating and Maintaining Safe Environments**

## 1. Children and young people's participation in the parish.

Parishes were asked if they had any activity involving children or young people organised by the parish in either the church or anywhere else, not including preparation for Holy Communion/Confirmation where the school takes responsibility for the preparation of the children for the sacrament and the involvement of the parish is for example a monthly preparation mass.

This year the audit captured the parishes who had children's activities in 2023. 34 out of 50 parishes responded that they had at least one children's activity, (the same as 2022 where 34 parishes reported having at leave one youth activity).

The most dominant organised activity was altar serving (28), followed by preparation for sacraments (17). It was noted that only 3 parishes recorded in their audit that they had the JPII Awards available for young people, however, from speaking to the Diocesan Faith Development Team over 20 parishes were registered as having taken part in the programme for 2023. Clarification to be sought by the Director of Safeguarding on this matter.

If a parish answered yes to the previous question, they were asked to complete the following thus the following section is based on the 34 parishes who had some activities for children.

There is strong adherence to the requirement for children and parents signing the joint consent form. While it is not explicitly stated in the data, the reason for non-use of consent forms could be related to adult and children's choirs where children only attend with a family member and some parishes First Holy Communion and Confirmation activities are held with parents present.

There is a strong practice of giving the safeguarding leaflets to children and their parents and this practice is promoted in all safeguarding training sessions.

The most widely used registers are with altar servers (sacristy register) and this is reported to be signed by all children and supervising adults in 27 of the 28 parishes with altar servers. One parish maintains a separate register for servers as they do not enter the sacristy at any time prior, during or following Mass. Parishes reported a strong compliance with using registers for other children's activities, with only one parish saying they are not using registers. The Director of safeguarding to follow up with this parish directly and explain importance of well-kept attendance registers.

On looking at the replies to question 10, there may have been some confusion, as almost all the activities mentioned happened as part of weekend masses with the priests present with very few exceptions, so the 14 parishes responding 'not applicable' is not a true reflection of the situation. Also 3 parishes who don't have activities with children answered these questions in error, skewing the results slightly.

Compliance with the completion of risk assessments is an area which requires improvement. Only 14 out of 34 parishes with youth activity have risk assessments in place. 6 parishes replied no and 15 parishes responded n/a when in fact they are applicable as all activities with minors require a risk assessment.

Safeguarding Meetings have been held in pastoral areas since the completion of the 2023 audits, providing clarity on risk assessments and support to parishes with the completion and implementation of them. A sample safeguarding risk assessment for youth activity is available on the Diocesan website kandle.ie

There is a strong compliance with the need for external groups using parish property to have sought permission from the Parish Priest. However, 10 parishes, reported that they do not have the necessary forms indicating that external groups have their own insurance and own child safeguarding policies in place. Some of those parishes commented that they would follow up on this. The 20 parishes who chose n/a do not have any external groups functioning in their parish at present.

Safeguarding Meetings have been held in pastoral areas since the completion of the 2023 audits, providing clarity on External Groups using parish property.

For most parishes with activities, there is compliance with keeping the required lists. However, improvement is needed when it comes to naming people who are in lead roles/in charge of the groups.

Only 15 parishes have lists of non-parish groups using church property, with many commenting that they would follow up on this.

N/A answers were given by parishes who have no groups.

In relation to passing on safeguarding complaints, one parish responded with a 'no.' Director of Safeguarding sought clarification from the parish and they clarified that they had no concerns to report which reflects full compliance in this area. All other parishes responded either yes or N/A, meaning they had no complaints/concerns to pass on.

The results above reflect differing practices in parishes in the recruitment of parish personnel such as cleaners/readers/eucharistic ministers/sacristans. Great improvement has been noted since the 2022 audit, but 18 parishes still reported "no" when it came to completed recruitment paperwork with these church personnel. From speaking to Local Reps and Priests, they report that there are many personnel who have been in place for 20+ years and these were verbal arrangements from that time. Clarity regarding recruitment practices has been provided at inter-parish safeguarding meetings in 2024 and is also part of the diocesan safeguarding training programme.

In relation to the questions concerning staff and volunteers who work with under 18's or vulnerable adults being recruited as per the standards, approximately one third answered with an N/A. It appears that the division of the question on recruitment in relation to working with over and under 18s has caused confusion.

Looking at the responses per parish, of the 34 parishes who said they had children's activities, only 16 had completed the necessary paperwork with staff/volunteers working with children. There may be individual reasons per parish for example where parents accompany their own children in the activity such as choirs, Communion/Confirmation activities, altar serving.

Of these 34 parishes, 30 have completed their Garda Vetting. 10 parishes reported that vetting is out of date. These parishes will be contacted directly. Some of these individuals may have roles with vulnerable adults which requires vetting clearance however, do not work with children.

Compliance with safeguarding training has continued to improve in 2023 since the return of training post Covid.

Above we ascertained that 34 parishes had children's activities and this table shows us that only 10 parishes held some safeguarding awareness activity with children and/or their parents. However, it is important to note that there was no Diocesan Safeguarding Sunday in 2023, this was held in Feb 2024. This is the main safeguarding initiative for children and parents in the Diocese, so compliance should be much higher next year.

There was a good reflection of support provided by priests to safeguarding representatives with 42 parishes reflecting formal or informal support in place. The 8 parishes who answered no will be contacted directly to offer guidance on this.

The audits reflect an improved link between safeguarding personnel and parish pastoral councils since 2022. Some of the 'No's' or N/A's' indicated there are no pastoral councils, or no meetings were convened in 2023.

There is strong compliance with good practice on the storage of records and information with almost all parishes saying they have locked storage facilities for documentation. However approximately a quarter of parishes do not have blank 'complaints or incident/accident' forms available. On further communication with parishes on this, they state that they know how to access these forms via the Diocesan website if required.

9 parishes cited not having 'The Towards Healing' poster on display at the time of the 2023 audit. Compliance with this request to have posters on display has greatly improved since 2022. The 9 parishes who answered 'No' have been contacted directly and posters provided.

#### **Final Questions**

At the end of the form parishes were asked to let us know the roles and estimated training needs for safeguarding training 2024. 29 parishes requested a combination of information and refresher training with a small number requesting full day training.

It is noteworthy that 7 separate training events have been held in the Diocese of Kildare & Leighlin between Feb 2024 and June 2024, thus meeting some of the training needs cited in the 2023 audits already.

Parishes were asked if there was any way in which the Safeguarding Committee or Director of Safeguarding can support them in their safeguarding work. Very few parishes entered a response in this section, examples of those who did are as follows;

"More information on External Groups"

"Vulnerable Adults not defined"

"Ongoing Communication re: changes of diocesan safeguarding requirements."

"Guidance on the Audit Form"

"Local Area Meetings Good Idea"

"Paperwork for Children's Activity"

"Difficulty getting Volunteers"

"Less red tape and paperwork."

"Thanks for the good work."

#### **Comments**

Unlike the 2022 audits there was not full compliance in return of the audit forms for 2023 with 6 parishes outstanding. These have all been contacted directly by Director of Safeguarding and there will be follow up.

Of the 50 parishes who returned their audits, overall, there appears to be a strong awareness and compliance with the requirements of safeguarding in parishes.

Areas of strength include communicating our safeguarding message with posters and leaflets being displayed as required and safeguarding representatives' names being made available locally. Another area of strength is adhering to creating and maintaining a safe environment in the use of joint consent forms and use of registers. There is still scope for improvement in our recruitment processes but there have been clear advancements since 2022.

Compliance with Safeguarding Training is strong in the Diocese.

In a small number of parishes (8), the audit reflects scope for improvement in the links between local safeguarding representatives and their local priests. The audit also reflects weak links between parish pastoral councils and safeguarding representatives.

While there has been improvement since 2022 with localised risk assessments, this is still an area of weakness, 15 parishes of the 34 with children's activities citing "n/a" even though all activities with minors require a RA.

Since the completion of the 2023 audit, inter-parish safeguarding meetings have been convened by the Director of Safeguarding with a particular focus on RA's, so it is hoped there will be improved compliance in the 2024 audit.

The area of recruitment is an area where small improvements have been noted since 2022, but there are still ongoing weaknesses in this area, particularly checking references of those working with u18s.

Unfortunately, the 2023 Audit shows that the level of participation of children and young people in our parishes remains largely unchanged. Only 34 out of 50 parishes who responded have children or young people involved.

Anecdotally, some parishes report challenges in getting young people and their parents involved due to clashes with other activities such as sports, dance etc. They also report challenges in getting adult volunteers, especially due to the paperwork, vetting etc.

It is important to state that some parishes in our diocese have thriving youth ministries with a strong culture of youth involvement, and it is hoped that youth participation will grow in 2024 as particular focus is given to youth participation from a diocesan safeguarding level.

Findings from this audit will be used to inform the annual training and annual communication plans and indeed the review of the three-year strategic plan.
